AMENDMENT TO H.R. _____

After section 2, insert the following new section and make the necessary conforming changes in the table of contents:

SEC. 3. MAINTAINING DOMESTIC EMPLOYMENT.

The Administrator, in consultation with the Secretary of Labor, shall annually prepare and certify a report to Congress on the average national unemployment rate for the prior year. If the Administrator determines, in consultation with the Department of Labor, that the unemployment rate for the prior year meets or exceeds 15%, as a result of implementation of this Act, the provisions of this Act shall cease to be effective.
