OFFERED BY MR. SULLIVAN OF OKLAHOMA

At the end of title V of division C, add the following:

1 **Subtitle F—Termination of**
2 **Duplicative Grant Programs**

3 **SEC. 2551. STUDY AND REPORT.**

4 (a) **STUDY.**—The Secretary of Health and Human
5 Services shall conduct a study to determine if any grant
6 program established by this division, or any amendment
7 made by this division, is duplicative of one or more other
8 Federal grant programs under the authority of the Sec-
9 retary in existence as of the date of the enactment of this
10 Act.

11 (b) **REPORT.**—Not later than 1 year after the date
12 of the enactment of this Act, the Secretary shall submit
13 to Congress and make available to the public a report that
14 contains the results of the study required under subsection
15 (a).

16 **SEC. 2552. TERMINATION OF DUPLICATIVE GRANT PRO-**
17 **GRAMS.**

18 If the Secretary of Health and Human Services deter-
19 mines under section 2551(a) that any grant program es-
20 tablished by this division, or any amendment made by this

1 division, is duplicative of one or more other Federal grant
2 programs under the authority of the Secretary, the Sec-
3 retary shall, to maximum extent appropriate, terminate
4 such other Federal grant programs not later than 180
5 days after the date of the submission of the report under
6 section 2551(b).
