## AMENDMENT #28

### OFFERED BY MR. BURGESS OF TEXAS

Strike subtitle B of title II of division A and the conform table of contents appropriately.

In section 100(a)(3)(b), strike the comma and all that follows before the semi-colon.

In section 100(c)(11)—

(1) in paragraph (11), strike “and includes the public health insurance option”;

(2) in paragraph (19), strike subparagraph (C) and redesignate subsections(D) and (E) as (C) and (D), respectively;

(3) in paragraph (20), strike “and includes the public health insurance option”; and

(4) strike paragraph (21) and redesignate paragraphs (22) through (25) as paragraphs (21) through (24), respectively.

In section 201(a), strike “, including a public health insurance option”.

Add at the end of subtitle A of title II of division A (relating to the health insurance exchange) the following new section:

#### **SEC. 209 PROHIBITION ON USE OF FEDERAL FUNDS FOR PUBLIC HEALTH INSURANCE PLAN.**

Federal departments, agencies, or other federal entities may not use federal funds to establish a federally-funded qualified health benefits plan.
