1 **SEC. ____ . LIMITATION ON ABORTION FUNDING.**

2 No funds authorized under this Act (or an amend-
3 ment made by this Act) may be used to pay for any abor-
4 tion or to cover any part of the costs of any health plan
5 that includes coverage of abortion, except in the case
6 where a woman suffers from a physical disorder, physical
7 injury, or physical illness that would, as certified by a phy-
8 sician, place the woman in danger of death unless an abor-
9 tion is performed, including a life-endangering physical
10 condition caused by or arising from the pregnancy itself,
11 or unless the pregnancy is the result of an act of [REDACTED]
12 rape or incest.
