**AMENDMENT TO THE AMENDMENT IN THE
NATURE OF A SUBSTITUTE TO H.R. 3200
OFFERED BY M . _____**

(AINS-EC_001)

At the end of subtitle F of title II of division B, add the following new section:

1 **SEC. 1761. VERIFICATION REQUIREMENTS TO PREVENT IL-**
2 **LEGAL ALIENS FROM RECEIVING MEDICAID**
3 **BENEFITS.**

4 Section 1904 of the Social Security Act (42 U.S.C.
5 1396c) is amended—

6 (1) by striking “If the Secretary” and inserting
7 the following:

8 “(a) OVERSIGHT.—If the Secretary”; and

9 (2) by adding at the end the following new sub-
10 section:

11 “(b) PREVENTING ILLEGAL ALIENS FROM RECEIV-
12 ING MEDICAID BENEFITS.—

13 “(1) VERIFICATION AS CONDITION ON FUND-
14 ING.—Notwithstanding any other provision of law,
15 no unauthorized aliens shall be eligible for any item
16 or service furnished under this title. The Secretary
17 shall not provide funding under 1903(a) for medical

1 assistance provided to an individual unless such indi-
2 vidual has been determined to be eligible for medical
3 assistance under this title on the basis of—

4 “(A) United States citizenship or nation-
5 ality through the verification process described
6 in section 1903(x); or

7 “(B) qualified alien status through the im-
8 migration status verification system described
9 in section 1137(d).

10 “(2) RULE OF CONSTRUCTION.—Nothing in the
11 America’s Affordable Health Choices Act of 2009 or
12 the amendments made by that Act shall be con-
13 strued as exempting any individual from the eligi-
14 bility verification requirements specified in para-
15 graph (1).”.
