**AMENDMENT**

**OFFERED BY MR. ROGERS OF MICHIGAN**

**[Amendment to HRDraft1]**

Add at the end of part 2 of subtitle D of title I of division B (relating to Medicare Advantage consumer protections) the following:

1 **SEC. \_\_\_\_ . PROTECTING CURRENT MA PLAN COVERAGE**  
2 **OF SENIORS.**

3 The Secretary of Health and Human Services shall  
4 not implement the provisions of this part and part 1 for  
5 any year unless the Secretary certifies for such year that  
6 none of the provisions of such part would result in any  
7 senior who would otherwise be enrolled in a MA plan  
8 under part C of title XVIII of the Social Security Act  
9 being forced away from or losing that senior's enrollment  
10 in such MA plan, as such enrollment was in effect as of  
11 the day before the date of the enactment of this Act.
